Eligibility: This competition is open to all competitors who are individual members of USA Shooting.

Teams: Unfired three person Mens and Womens Team Matches will be available.

Categories: The following categories will be used for individual and team competition:

(Based on the age the competitor is in the year 2009)

Open

Junior (J1); age 18-20; competitors born from 1989-1991

Intermediate Junior (J2); age 15-17; competitors born from 1992-1994

• Sub-Junior (J3); age 14 & under; competitors born in 1995 or later.

Classification: There will be no class based award schedule.

Rules: Current USA Shooting Rules will govern.

Course Of Fire: As per USA Shooting requirements:

Men will fire 60 shots standing.

• Women will fire 40 shots standing.

Time Limits: Two AR5/10 targets will be posted simultaneously. Shooters will be allowed 35 minutes

to fire 20 record shots. 5 minutes will be allowed for each target change. 10 minutes will

be allowed for preparation period.

Firearm: Any 4.5 mm caliber air rifle conforming to USA Shooting rule 4.6.

Sights: Metallic, USA Shooting rule 7.4.2.3.

Distance: 10 Meters

Targets: AR5/10, 12 bulls (2 sighting) per target.

Coaching on the firing line will not be permitted.

Scoring Protests: A scoring protest of \$1.00 per shot may be charged.

Ties: All ties will be broken in accordance with USA Shooting Rules.

Awards: Award plaques will be presented to the top three Men's competitors and the top three

Women's competitors.

Make Entry: Entries may be made via e-mail, phone or mail to the contact person shown at the top of

the first page.

Entry Fees:
A USA Shooting registration fee of \$8.00 per individual, per event will be charged.

• A match fee of \$12.00 per competitor will be charged.

Total individual entry fee: \$20.00Optional Team entry fee: \$6.00

Entries Close: Entries are limited to 28 total competitors (7 per relay).

Advance entries will close Sunday, 11/01. Entries will be accepted to range capacity. Every effort will be made to accept all competitors who enter before the closing date.

Post Entries: Entries made after the closing date will be accepted up to range capacity. A post entry

fee of \$5.00 will be charged.

Cancellations: Cancellations received one week in advance, or earlier, will receive a full refund.

Schedule Of Events:

Relays will be:

• Friday, 11/06 – 6:30 PM

Saturday, 11/07 at 9:00 AM, 12:00 Noon and 3:00 PM (only if earlier relays fill)

Preparation time will begin 10 minute prior to the relay start time. The range will be open one hour prior to the relay time.

Directions To Range:

<u>From the West</u>: Take NH Route 101 East to Route 101A East, to the Everett Turnpike South.

From the North: Take 193 South, to the Everett Turnpike South.

<u>From the South</u>: Take Rt. 128/95 or Rt. 495 to Rt. 3 North towards NH. Rt. 3 becomes the Everett Turnpike North.

From the Everett Turnpike: Take Exit 2 off of the Everett Turnpike and follow the signs toward Hudson going over the Merrimack River. After crossing over the Merrimack River stay in the right lane and turn on to Route 3A South (Sam's Club will be on the right and Wal-Mart will be on the left) At the 3<sup>rd</sup> set of lights continue straight (in the right lane) to continue on Route 3A South. Continue approximately 1 ½ mile to the next set of traffic lights. (Watch for the Hudson Fish and Game Club sight on the left at the lights) Turn left at the traffic lights onto Pine Road. The Hudson Fish and Game Club is ¼ mile down Pine Road on the left. Use the glass door entrance at the left.
