Cancellations and requests for a refund must be made in writing. Refunds will not be made until written request is received. No refunds will be made to individuals who do not show up at the National Metric Championships and make no attempt to contact the NRA Rifle Department or the Championship Statistical Office.

Requests for "Refund of Entry" fees will be honored up through July 14th. A handling fee of \$25.00 will be charged for all refunds. Refunds due to emergencies such as injury or death will be 100% honored, but must be made in writing.

11. SQUADDING

Squadding will be done on a first-come-first served basis. Squadding will be done by the NRA Rifle Department as paid registrations are received. Competitors who wish to shoot together, or clubs who wish its members to be squadded together, must enter the championship together.

Competitors will be squadded on the same firing point through the match.

Squadding for competitors, who enter after July 9, will be squadded by the Range Director.

12. COURSE OF FIRE

The Course of Fire is 2 days of 120 shots fired in each of 3 positions, Prone, Standing, and Kneeling (fired in that order). In each position, 40 shots will be fired with unlimited sighting shots allowed. Day-1 will be fired using metallic sights and Day-2 will be fired using any sights. The National Championship Aggregate is a combination of the Metallic Sight Championship and the Any Sight Championship.

Team Matches will be non-fired (Paper Matches) entries. Teams will be made up of two people in accordance with Rule 2.11 Club Teams and Rule 2.12 State Association Teams. The Course of Fire is the same as the individual championship for metric sights and any sights (120 shots).

Firing will begin at 8:00 am each day. Relays start times will change between the Metallic Day and the Any Sight Day for the Championship. During each day the Relays will alternate firing order (i.e., Relay 1 fires Prone then Relay 2 fires Prone, etc.).

13. COMPETITOR CLASSIFICATION

Rule 19.14 Score Book (Temporary Classification) will not be used.

Rule 19.6 Assigned Classification may be used.

Competitors who do not hold an NRA Official Classification, either in the type of competition being fired, or an Assigned Classification will be placed in the Master Class.

Junior competitors who are members of the Service will compete as Service Competitors.

Top three (3) winners in fired matches will be removed from Class awards.

One Class award will be provided for every five entries within the Master, Expert, Sharpshooter, and Marksman classes.

Classes with less than five (5) competitors will be combined with the next higher class (The Match Director may combine classes after determining the number of competitors actually firing in a match).

Competitors may be required to present evidence of their Classification at the Statistical Office.

15. BULLETINS

The Official Tournament Bulletin Board is maintained at the Statistical Office. Scores will be posted as matches are completed. Challenge Periods will be posted when the Official Preliminary Bulletin is posted on the bulletin board.

Competitors are reminded that it is their responsibility to check the Official Bulletin for Match Director's Bulletins and for the accuracy of their posted scores. Competitors are responsible for their own score after the Final Challenge Period has expired. The Statistical Office is responsible for ensuring that score or administrative challenges are posted prior to the end of the Final Challenge Period. Challenges for score will not be accepted after the Final Challenge Period.

16. CHALLENGES AND PROTESTS

Competitors and Team Captains wishing to make a challenge or protest are referred to NRA Rule 16. Persons other than competitors or team captains (in team matches only) are not eligible to make challenges or protests.

Team captains are not allowed to make either protests or challenges for an individual competitor in an individual match.

Challenges – Competitors or team captains (during the team matches) should check their posted targets and scores. If a competitor feels that a score, class, or category is incorrect, it is the competitor's responsibility to report this change to the Statistical Office for correction PRIOR TO THE END OF THE FINAL CHALLENGE PERIOD.

Score challenges will be given to the Challenge Referee who will rescore the target and adjudicate the challenge. The Challenge Periods will be posted on the Official Bulletin Board.

A Challenge Fee of \$1.00 is required for each Challenge. If the challenge is upheld, the Challenge Fee will be returned to the competitor.

Protests – All protests must be in accordance with NRA Rule 16.3 *How to Protest*. A nonrefundable Protest Fee of \$20.00 is required for each Protest.

In NRA Championships, no one other than a competitor, someone assisting a physically disabled competitor, or a team captain or coach may go forward of the ready line during team matches.


Smoking – Smoking is not permitted forwarded of the ready line.

Hearing Impaired Competitors – It is the responsibility of the hearing impaired competitor to inform the Range Officer each time they go forward of the firing line.



Team Entries

Team entries may be made at time of registration.

Cancellations and Refunds

Cancellations and requests for a refund must be made in writing. Refunds will not be made until written request is received. No refunds will be made to individuals who do not show up at the National Metric Championships and make no attempt to contact the NRA Rifle Department or the Championship Statistical Office.

Requests for "Refund of Entry" fees will be honored up through July 14th. A handling fee of \$25.00 will be charged for all refunds. Refunds due to emergencies such as injury or death will be 100% honored, but must be made in writing.

11. SQUADDING

Squadding will be done on a first-come-first served basis. Squadding will be done by the NRA Rifle Department as paid registrations are received. Competitors who wish to shoot together, or clubs who wish its members to be squadded together, must enter the championship together.

Competitors will be squadded on the same firing point through the match.

Squadding for competitors, who enter after July 9, will be squadded by the Range Director.

12. COURSE OF FIRE

The Course of Fire is 2 days of 120 shots fired in the Prone position at 50 Meters, a Metric Dewar Match, and a 100 yard metric Prone match (fired in that order). In each match, 40 shots will be fired with unlimited sighting shots allowed. Day-1 will be fired using metallic sights and Day-2 will be fired using any sights. The National Championship Aggregate is a combination of the Metallic Sight Championship and the Any Sight Championship.

Team Matches will be non-fired (Paper Matches) entries. Teams will be made up of two people in accordance with Rule 2.11 Club Teams and Rule 2.12 State Association Teams. The Course of Fire is the same as the individual championship for metric sights and any sights (120 shots).

Firing will begin at 8:00 am each day. Relays will switch relay start times between the Metallic Day and the Any Sight Day for the Championship. During each day the Relays will alternate firing order (i.e., Relay 1 fires Prone then Relay 2 fires Prone, etc.).

13. COMPETITOR CLASSIFICATION

Rule 19.14 Score Book (Temporary Classification) will not be used.

Rule 19.6 Assigned Classification may be used.

Competitors who do not hold an NRA Official Classification, either in the type of competition being fired, or an Assigned Classification according to rules 19.6, 19.16, 19.17, and 19.21 will be placed in the Master Class.

Junior competitors who are members of the Service, and receive support, will compete as Service Competitors.

14. AWARDS CATEGORIES

Category Awards will be awarded in the Aggregate matches only in the following categories. (There must be at least five (5) competitors in a category for an award.):

Top three (3) winners in fired matches will be removed from Class awards.

One Class award will be provided for every five entries within the Master, Expert, Sharpshooter, and Marksman classes.

Classes with less than five (5) competitors will be combined with the next higher class (The Match Director may combine classes after determining the number of competitors actually firing in a match).

Competitors may be required to present evidence of their Classification at the Statistical Office.

15. BULLETINS

The Official Tournament Bulletin Board is maintained at the Statistical Office. Scores will be posted as matches are completed. Challenge Periods will be posted when the Official Preliminary Bulletin is posted on the bulletin board.

Competitors are reminded that it is their responsibility to check on the Official Bulletin Board for Match Director's Bulletins.

Competitors should check the Official Bulletin board for the accuracy of their posted scores.

The Statistical Office is responsible for ensuring that challenged scores or administrative challenges are correctly posted in the Final Bulletin. Competitors assume responsibility for their scores posted in the Preliminary Bulletin after the Final Challenge Period has expired. Challenges for score will not be accepted after the Final Challenge Period.

16. CHALLENGES AND PROTESTS

Competitors and Team Captains wishing to make a challenge or protest must comply with the NRA Smallbore Rifle Rules Book, Section 16. Only competitors and team captains (for team matches only) are eligible to make challenges or protests.

Team Captains are not allowed to make either protests or challenges for an individual competitor in an individual match.

Challenges – Competitors or Team Captains should check their posted targets and scores. If a competitor feels that a score, class, or category is incorrect, it is the competitor's responsibility to report this change to the Statistical Office for correction PRIOR TO THE END OF THE FINAL CHALLENGE PERIOD.

Score challenges will be given to the Challenge Referee who will rescore the target and adjudicate the challenge. The Challenge Periods will be one hour after the Preliminary Bulletin is posted on the Official Bulletin Board.

A Challenge Fee of \$1.00 is required for each Challenge. If the challenge is upheld, the Challenge Fee will be returned to the competitor.

Protests – All protests must be in accordance with NRA Rule 16.3 *How to Protest*. A nonrefundable Protest Fee of \$20.00 is required for each Protest.

Target: A three bullseye, 100 yard, A-33 target will be used for each of two stages. The top bullseye is used for sighting shots and ten (10) shots will be fired at each of the record two (2) bullseyes.

Awards: Same as Match 600.

26. METRIC PRONE METALLIC SIGHT TEAM MATCH #T-402

Fired: Team matches are not fired matches. Scores from the individual Metallic Sight Championship are used to determine a team's score (paper match).

Open to: Two (2) person-teams (Must enter prior to firing the first shot).

Course of Fire: Scores from Match #700 will be used.

Awards:

A Team Award Category must have at least five (5) teams. Categories with less that five teams will be moved up into the next higher Category in the following order:

Sub-Junior \Rightarrow Intermediate Junior \Rightarrow Junior \Rightarrow Club Team \Rightarrow Open Team (State Association Teams will not be combined with any other teams). Teams must comply with Rules 2.11, 2.12, and 2.13.

In team matches, the team captain and/or the team coach may assist in the changing of targets and in moving equipment to and from the firing line.

Captains and/or coaches are permitted to assist competitors in changing and moving equipment to the and from the Firing Line.

In NRA Championships, no one other than a competitor, someone assisting a physically disabled competitor, or a team captain or coach may go forward of the Ready Line during team matches.


Smoking – Smoking is not permitted forwarded of the Ready Line.

Hearing Impaired Competitors – It is the responsibility of the hearing impaired competitor to inform the Range Officer each time they go forward of the Firing Line.


