Location: ISRA Range, Bonfield, Kankakee County, IL

Directions: From Dwight, approximately 21 miles East on Rt 17 to Warner Bridge Road.

From Kankakee travel west on Rt 17 to Warner Bridge Road (7000W), turn North,

travel 1.5 miles, range is the right (East).

From Chicago travel south on Interstate 57 to Manteno 322 exit. Travel west (right) on Manteno-Deselm (9000N) road to 7000W (two miles west of Deselm), turn south for approximately 7.5 miles (crossing Rt 102, Kankakee River and Rt 113). Watch for range

on the left (East).

Follow gravel lane east past pistol range and high power range into the woods for the 100

yard range.

Rules: This is a registered match. NRA Smallbore Rifle Rules will govern. Any rifle (Rule 3.2)

may be used.

NRA Membership: Competitor membership in the NRA is optional. Junior shooters must be born in 1990 or

later. All adult competitors must be ISRA members or members of the State Association

where they maintain their residence. State Champion will be an Illinois resident.

Classes: N.R.A. Classification (Rule 19) will apply.

Awards: Match awards (will be cash and trophy plaque) are provided based on total number of

competitors. Sponsor provided awards are based on classifications and categories at a rate of one award per 5 competitors. (Juniors will receive a plaque.) Traveling trophies will be awarded to Illinois residents only. The State Junior Championship will be based on

the aggregate (Match 5) of all iron sight matches.

Entries: Advance entries are requested by September 15, 2010. Advance entries will be

acknowledged, late entries will be taken up to 1/2 hour prior to scheduled relay start time and range capacity. Advanced entries take precedence. All matches will be

squadded.

Awards Schedule and Conditions for I.S.R.A. State Prone Matches

Conditions: There are 24 concrete and covered firing points. Competitors will change targets and be

responsible for hanging the correct target. Targets will be displayed. Competitors are permitted to shoot scope all matches, but will not be eligible for any metallic sights awards or Grand

Aggregate awards. A special high scope award will be given.

Awards: Awards will be cash, in accordance with the schedule below. No competitor will receive more

than one award in one match. Ranking of awards will be: Open, Classification, Junior, and Lady. Classification awards will be made only if there are 5 or more competitors in the class. When there are less than 5 in a class, classes will be combined from the lowest ranking unfilled (less

than 5) class.
