ELIGIBILITY: Open to all competitors. (Starting July 1, 2008, match sponsors will no longer be required to ask for proof of N.R.A membership for any N.R.A registered tournaments. Competitors need to be N.R.A members to set N.R.A national records, become a member of an honorary club, and to earn N.R.A distinguished steps. Competitors who are not N.R.A members will be assigned a number for classification purposes only). This will be a NRA-Registered Match.

CLASSES & CATEGORIES: The N.R.A. system will be used. If fewer than (5) entries in a class, competitors will be moved to their respective in the next higher class. Army National Guard members, full time military personnel and full time police officers will constitute the Service Class.

RULES: All current N. R. A. Small bore Rifle rules will be in effect throughout the competition.

N.R.A. Membership Number: In order that the competitor's scores may be entered into the Computer Classification System, their N.R.A ID number is required. Any junior competitors, who are individual members of the N.R.A., are also required to put their ID number on their entry card. If you are not a N.R.A. member, a number will be assigned you, for classification purposes only.

CLASSIFICATION: The N.R.A. classification system will be used for this tournament. Unclassified competitors will compete in the MASTER class. (Rule 19.6 – Assigned Classification) or temporary classification may also be used when making entry into a N. R. A. registered tournament (Rule 19.2 - Temporary Classification)

START TIMES: 9:00AM Saturday 9/25 8:00Am Sunday 9/26

SQUADDING: Squadding will be on a first come with preference given to the competitors who will be shooting the complete tournament. (Iron Sights on Saturday, Any Sights on Sunday). Additional competitors will be accepted, as range space allows without requiring the formation of another relay.

ADVANCE ENTRIES: Advance entries are requested. This will insure the competitor of his/her preference. The registration fee must accompany your entry.

POST ENTRIES: Will be accepted up to the limit of the range.

CHALLENGE FEE: A \$2.00 challenge fee will b assessed. (Rule 16). A fee of \$3.00 will be charged if the competitor wished to challenge the target of another competitor.

ENTRIES: Individual entries will close on Wednesday, preceding the match. (SEPTEMBER 25, 2010)

AWARDS: Awards will be CASH OR N.R.A. AWARD POINTS ONLY. There will be a OPEN winner, in addition to class awards in each match. If there are fewer than five (5) MASTERS, they will compete for the OPEN award only. Awards will be as follows: 5 Competitors 1st Place, more than 8 Competitors 2nd Place, more than 13 Competitors 3rd Place.
