

2010 CSRRA CONNECTICUT STATE 3-POSITION CHAMPIONSHIP

(Match Directors Bulletin #1—8/27/2010—changes in italics)

- Date/Time: September 11, 2010, 9AM Relay *(only one relay—limited to 40 competitors)*
- Location: Blue Trail Range, 316 N. Branford Road, Wallingford, CT, 06492, (203) 269-3280
- Eligibility: Open to all as defined by NRA Rule 2.3, NRA Membership is not required.
- Rifle: NRA Rule 3.2
- Sights: Metallic Sights *(Match 1/2/3/4/10)*; NRA Rule 3.7c Any Sights *(Match 5/6/7/8/11)*.
- Targets: *A-51 Target (changed to this target to meet requirements of Match #12).*
- Classifications: NRA Classification system will be used. Temporary classification scorebooks are acceptable. Classes with less than 5 entries will be combined with the next higher class.
- Entries: Advance entries are suggested due to range capacity of 40 shooters.
- Matches: Match 1 – 20 shots Prone, Metallic Sights
Match 2 – 20 shots Standing, Metallic Sights
Match 3 – 20 shots Kneeling, Metallic Sights
Match 4 – Iron Sight Aggregate (Matches 1-3)
Match 5 – 20 shots Prone, Any Sights
Match 6 – 20 shots Standing, Any Sights
Match 7 – 20 shots Kneeling, Any Sights
Match 8 – Any Sight aggregate (Matches 5-7)
Match 9 – Grand Aggregate (Matches 4 & 8) *State Champion must be Resident of Connecticut. If Match Winner is a non-resident, a like award of same value will be awarded).*
Match 10 – Metallic Sight Unfired 2-man Team Match—Score from Match 4
Match 11 – Any Sight Unfired 2-man Team Match—Score from Match 8
Match 12 – *NRA State Smallbore Rifle 3-Position Team Postal Match (Paper Match—Scores will be used from the ten high scoring state resident competitors from Match 4). No person may be a member of more than one state each year for the same type of competition.*
- Fees: Registration Fee \$5.50
Range Fee \$12.00
Match Fee \$2 per match (\$18 Total—9 Matches)
Package Fee: \$35.50
Team Fee: \$6 per Team (Unfired—Score from Match 4 and Match 8)
- Challenge Fee: \$1.00 per own target, \$3.00 for another competitor's target
- Awards: Will be given to match winner and 1st in each class provided there are 5 or more entries in the class. An additional award will be given for each additional 5 entries per class.

From I-91 South, take exit 15, and take a left onto Rt. 68, See below.
Follow Rt. 68 about 1 mile to stop light. Turn left at light and continue on Rt. 68 for 1 mile.
Turn Right on North Branford Rd, Range is approx 1 Mile on Left.
