Location:

RBGC is approximately 60 road miles north of downtown Atlanta in the southwest corner of Dawson County, 15 miles from Dawsonville, GA. For driving directions to the club, please refer to the interactive map on our web site at www.rbgc.org. From the home page click on "Club Information" and then click on "Get Directions To RBGC".

Facilities:

The competition forum, RBGC's Multi-purpose II range (MP2), has 40 paved and covered firing points. For those who would like to practice, an open practice session will be held on Friday afternoon, October 15.

RV parking is permitted at MP2 and the club also has a pleasant area designated for camping. Clean rest rooms and a limited number of RV water and electric hook-ups are also available at MP2. If you plan to practice or camp, please contact the match director or RBGC club manager before you unload your competition or camping equipment.

Please Note - All competitors must sign an RBGC liability release <u>before</u> practicing and/or competing. Liability releases for junior competitors must be signed by an adult guardian. Also, please remember that RBGC guests are limited to use of the MP2 range during open practice or competition while a member of the match staff is present. Should you need to use MP2 or any other range when the match staff is not present, club rules require that guests be signed-in and accompanied by an RBGC member at all times. Please direct any questions about these requirements to Tommy Steadman, the match staff, or the RBGC club manager.

Lodging:

Lodging accommodations are conveniently located within a reasonable driving distance of the range in Cumming, Canton, Dawsonville and Gainesville. Please see the lodging listings on our web site at www.rbgc.org. From the home page click on "Club Information" and then click on "Nearby Motels and Restaurants".

Food & Beverage:

There are no snack or restaurant facilities at RBGC or nearby and we recommend that you bring lunch, drinks, and a snack.

Rules:

Current NRA Smallbore Rifle Rules will govern. The .22 Caliber Rimfire Rifle as defined in NRA Smallbore Rifle Rules 3.2 (Any Rifle) applies. Per Rule 3.21, the requirement for a smallbore empty chamber indicator (ECI) to indicate that the chamber is empty will be strictly enforced.

As provided in NRA rules, this is a simultaneous dual championship tournament in which a paper match Metric State Championship will use the Regional Championship scores of Georgia residents who register to compete for the state championship to crown the 2010 NRA Smallbore Rifle Prone Metric State Champion.

Eligibility:

The <u>Metric Prone Regional Championship</u> is open to all competitors and membership in the NRA and/or Georgia Sport Shooting Association (GSSA) is not required.

The <u>Metric Prone State Championship</u> is a distinct and separate NRA Registered tournament fired concurrently with the Metric Regional and requires competitor registration. Those competing for the Metric Prone State Championship must also register for the Metric Regional Prone Championship

Championship.

Eligibility: (Continued)

Each competitor in the Metric Prone State Championship must be a Georgia resident (Rule 2.20) <u>and</u> must be a member of Georgia Sport Shooting Association (GSSA). Membership in the NRA is not required. Junior competitors may be a member of the NRA or a member of an NRA-affiliated club in lieu of GSSA membership.

Teams will consist of two (2) firing members assigned by the statistical office based on each competitor's score in Match 1, Metallic Sight Dewar Match (see description of Odd Ball Team Match on pages 5 and 6 of this program). Competitors must compete in Match 1 to be eligible for the team match.

Entries Close: Individual match entries must be received no later than October 14, 2010.

Entries Limited: Entries are limited to 80 individual competitors. Team entries are limited to forty

individuals.

Advance entries will be accepted up to range capacity based on earliest postmarks. Entries beyond range capacity will be notified by e-mail or telephone on or about October 14.

fee for post entries but advance entries are appreciated.

Squadding:

All matches, including team matches, will be squadded by the Statistical Office. All competitors must check-in at the Statistical Office to obtain squadding tickets. A competitor squadding report for individual matches will be posted on the Statistical Office bulletin board on Saturday morning prior to Match No. 1. Squadding for the team match will be announced on the range. Failure of a competitor to obtain his squadding ticket or to present himself at the proper firing point when his relay is called may lose his right to compete in that event.

Post entries (or advance entries whose NRA classification could not be verified online) may be asked to present NRA classification cards at time of registration.

Squadding Preference Will Be Given To Full Program Entries.

Classification:

The NRA classification system will be used in all individual matches. Individual competitors without an NRA classification will fire in the Master Class. Rule 19.6 (assigned classification) or Rule 19.2 (temporary classification) may be used.

Class/Category: Separate awards will may given in each of foue categories, Service, Civilian, Senior and Junior, subject to Regional Award schedule. Members of the Army, Navy, Marine Corps, Coast Guard, Air Force, National Guard and Reserve components will comprise the Service Category (Rules 2.5, 2.6 and 2.7). All others are either Civilians (Rule 2.2), Seniors (Rule 2.2.1) or Juniors (Rule 2.3). Classes and categories may be combined (Rule 19.8).

Any Sight 2400: Individual competitors may shoot any sights both days and thus compete in a separate any sight group. Awards will be per a special any sight award schedule. A minimum of five competitors is required to receive Any Sight Group awards and this group is not eligible for any of the Metallic Sight 1200 class or open awards (matches 1 through 4) awards or Regional 2400 Aggregate Open awards (match 9). Competitors in the Any Sight 2400 group will be eligible for awards only within the any sight group (subject to group size criteria) and for the any sight portion of the program [matches 5 through 8]).

Targets:

Official NRA Conventional targets will be used: A-50 at 50 meters and A-33 at 100 yards. Competitors will mark and hang their own targets before each match stage. Target clips are required and must be furnished by each competitor. Targets will be scored by the Statistical Office staff under the supervision of the Chief Statistical Officer. Scored targets will be available for inspection by competitors in the Statistical Office.

Challenges:

Challenges and protests will be addressed as described in Rule 16. A \$2.00 challenge fee will be charged for each challenge and collected by the Statistical Office before making the first recheck. The challenge fee will be returned if the challenge is sustained at any point along the line of rechecks. Challenge time limits for each match will be posted on the Statistical Office bulletin board.

Scoring Of Challenged Shots And Shots Of Questionable Value: In this tournament, the plug type scoring gauge will be restricted to use by range operating personnel including range officers, chief statistical officer, and one or more of the three members of the jury who will be selected prior to firing time.

Schedule Of Awards:

Awards Furnished By The NRA:

Individual Regional 2400 Championship Awards - Match No. 9, 2400 Grand Aggregate

NRA Regional Gold Medallion

2nd Place: NRA Regional Silver Medallion (requires minimum 10 competitors) 3rd Place: NRA Regional Bronze Medallion (requires minimum 15 competitors)

Team Regional Championship Award - Match No. 10, 2-Man Team Championship A medal will be awarded each member of the winning team.

Souvenir Pins: An NRA Regional Championship souvenir pin will be given to each competitor.

NRA National Smallbore Rifle Championship Certificate Award: Certificates for 50% off Camp Perry entry fees will be awarded to winners of each class with at least 10 competitors. Only one certificate will be awarded per class of 10 or more. Classes may be combined upward (NRA Rule 9.8.1) to make a class of 10 competitors. No certificates will be awarded if there are fewer than ten total competitors entered in this Regional tournament.

Competitors may earn a maximum of one prone certificate and one position certificate per year. Both certificates may be applied to the National Smallbore Rifle Championships if the certificate winner competes in both championships.

Certificates won by an ineligible competitor will be passed down to the next lower competitor in that class (e.g., if the class winner has already won a prone certificate at an earlier Regional prone tournament or is a supported shooter). Certificates awarded to competitors remain the property of the NRA which may refuse to honor any certificate for any reason at anytime,

Awards Furnished by River Bend Gun Club:

Regional Championship Match and Class Winners of individual fired matches, 1200 aggregate matches, and 2400 grand aggregate match (other than junior competitors paying reduced match entry fee) will receive cash and/or award points. The value of awards will be based on an award schedule designed to equitably distribute awards to competitors based on the number of entries in each class and category. The total amount of funds available for awards distribution will be approximately 60% of total receipts less tournament expenses (NRA registration fees, RBGC range fees, target costs, etc.).

A minimum of 5 entries is required to form a class/category. Second place awards will be presented with 8 or more entries in a class/category. Third place awards will be presented with 15 or more entries in a class/category. Classes with insufficient entries to meet the minimum entry criterion will be moved to a higher class (Rule 19.8.1).

We invite competitors and others to sponsor an individual match or matches or any special or fun award. Such aggrandizement or largess will bear the name of the donor.

Other RBGC Regional Championship Awards:

High Scoring Senior: (Rule 2.2.1): NRA Medal (requires minimum 5 shooters in category). High Scoring Junior: (Rule 2.3): NRA Medal (requires minimum 5 shooters in category).

<u>Metric Smallbore State Championship</u> - The high scoring adult Georgia resident and high scoring junior Georgia resident in Match 10 who are also entered in the State Championship will earn the titles of 2010 Metric Smallbore Prone Georgia State Champion and 2010 Metric Smallbore Prone Junior Georgia State Champion respectively and each will receive a suitable medal, plaque, or trophy in recognition of their championship title.

"Odd Ball" Team Match - Match No. 12:

In an attempt to encourage and stimulate team match participation, the 2-man team match is a "fun event" with teams assigned by the sponsor as explained below. The match sponsor is hopeful that all individual competitors will join the fun.

Eligibility: This is an "open" team match and there is no club or organizational affiliation requirement.

Teams are not eligible to establish NRA national records.

Entry: The team match is a sponsored event and there is no team entry fee for competitors. <u>Competitors</u>

may enter the team match by notifying the Statistical Office before the start of Match 1, Dewar

Match Metallic Sight.

Awards: Each member of the winning team will receive an NRA team medal. If more eight or more teams

compete, a medal will be awarded to each member of the second place team.

Course Of Fire: The Odd Ball team match is an Any Sight 400 aggregate match with 20 shots for record fired by each team member. The distance will be 50 meters fired on target A50. A three minute

preparation period will be followed by twenty minutes for unlimited fouling and/or sighting shots and

twenty shots for record.

The highest possible team score is 400-40X. Ties will be broken per Section 15 of NRA Smallbore Rifle Rules.

Team Assignment: The Statistical Office will assign teams from the roster of individual competitors who register to compete in the team match. Team assignments will be made based on the scores fired in the Dewar

Match Metallic Sight (Match No. 1) as follows:

Team competitors will be ranked-ordered from high to low based on their score in Match No. 1, Metallic Sight Dewar Match. The competitor with the highest score in Match No. 1 will be teamed with the competitor with the lowest score in Match No. 1. The competitor with the second highest score will be teamed with the competitor with the second lowest score and so on until all competitors are assigned to teams.

"Odd Ball" Team Match - Match No. 12: (Continued)

The "Odd Ball": If an odd number of individual competitors register for the team match, the "odd ball" (individual without an assigned team member) will be given the option of accepting a stipend in lieu of competing or competing with all other teams plus firing a supplemental 20 minute/20-record shot stage at the conclusion of the team match. If the "odd ball" declines the stipend and elects to compete in the team match, he or she may recruit a non-firing teammate/coach if such person is readily available. If the "odd ball" wins the team match or is eligible for a second place award, the non-firing teammate/coach will be awarded a team medal.

Squadding:

Team members will be squadded on adjacent firing points to facilitate team member communication and coaching. Firing points will be assigned by the Statistical Office and will be available when the team assignments are announced.
