CITY / STATE LOCATION: WEST POINT, NEW YORK

ELIGIBILITY: This competition is open to all competitors born in 1990 or later. All competitors must be individual members of USA Shooting.

RESIDENCE: Each competitor may claim residence in only one state and must declare the state of residence on the entry form. Residents are eligible for the 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> place USA Shooting State Championship medallions. Non-residents may compete for automatic and at-large invitations to the National Championship and are encouraged to do so.

**STATE RESIDENT**

QUALIFIERS: USA Shooting will issue official invitations to the National Junior Olympic Shooting Championships (NJOSC) for the high scoring male and high scoring female resident from each State JOSC, provided they fire a minimum qualifying score. Resident collegiate and/or military competitors are eligible for the state resident champion awards and are also eligible for resident state qualifier invitations.

ENTRY: Shooters ***may not*** compete in more than one state JOSC. Juniors who fire in their own home state JOSC will not be allowed to shoot in another state. Juniors from states which are not holding a state

JOSC and those who cannot attend their own state JOSC will be allowed to enter the automatic/at-large division in another state. At entry, non-resident juniors must declare that they are shooting for an at-large/automatic invitation.

Residents may choose to enter the Automatic/At-large category instead of the Resident Qualifier category if they are confident they can shoot above the automatic score and secure an invitation. This would allow another competitor to receive the State Qualifier invitation.

- A. **Resident Qualifier** – Competitors shooting in their declared state of permanent residency. Competitors in this category are eligible to be the state resident qualifier to the National JOSC.
- B. **Automatic/At Large** – Competitors shooting in other than their declared state of residency are eligible for at-large/automatic invitations to the National JOSC.

CATEGORIES: The following categories will be used for individual and team competition:

(Based on the age the competitor will be in the year 2010.)

Junior (J1); age 18-20; competitors born from 1991-1993

Intermediate Junior (J2); age 15-17; competitors born from 1994-1996

Sub-Junior (J3); age 14 & under; competitors born in 1997 or later.

CLASSIFICATION: Current International card or temporary book.

RULES: The 2010 edition of USA Shooting Rules will govern.

COURSE OF FIRE:

SMALLBORE- 60 shots (3x20) for both men and women at 50 feet.

AIR RIFLE- 60 shots for men and 40 shots for women at 10 meters, using .177 caliber air rifles

TIME LIMIT:

SMALLBORE: 2 hours, 30 minutes OR if changing targets between positions- 40 minutes prone, 60 minutes standing, 50 minutes kneeling.

AIR RIFLE: Men's: 60 shots; 1 hour, 45 minutes.

Women's: 40 shots: 1 hour, 15 minutes.

FIREARM: Per 2005 edition of USA Shooting Rules.

SIGHTS: Per 2005 edition of USA Shooting Rules.

DISTANCE: Smallbore: 50 ft.  
Air Rifle: 10 meters

TARGETS: USA Smallbore and Air Rifle Targets.

COACHING: Coaching on the firing line will not be permitted.

#### SCORING

PROTESTS: A scoring protest of \$1.00 per shot may be charged.

TIES: All ties will be broken in accordance with USA Shooting Rules.

#### PARTICIPATION

PINS: A Junior Olympic participation pin provided by USA Shooting will be given to each competitor (provided pins are requested by the sponsor).

AWARDS: **Provided by USA Shooting** – USA Shooting will provide a gold medallion for the top resident individual, silver medallion for the 2<sup>nd</sup> place resident individual and a bronze medallion for the 3<sup>rd</sup> place resident individual. Unused awards must be returned to USAS.

*Provided by the Sponsoring Organization –*

SCORE SHEETS: **Special score sheets must be used for all State JOSCs.** They are to be filled in completely and signed by the competitor to be considered for invitation to the National JOSC. **LEGIBLE** handwriting is required. If we cannot read your handwriting you may not get your invitation.

MAKE ENTRY: Entries should be made using the entry form enclosed with this program. Mail entries to the contact person shown at the top of the first page.

ENTRY FEES: A USA Shooting registration fee of \$8.00 per individual, per event will be sent to USA Shooting with scores at the completion of the match.

Total individual entry fee:

If competing in both events: \$30  
If competing in only one event: \$23.

**ENTRIES CLOSE:** Advance entries will close **1 December 2010**. Entries will be accepted to range capacity. Every effort will be made to accept all competitors who enter before the closing date.

**POST ENTRIES:** Entries made after the closing date will be accepted up to range capacity. A post entry fee may be charged.

**CANCELLATIONS:** Cancellations received one week in advance, or earlier, will receive a full refund. An additional refund schedule may be used.

**SCHEDULE OF  
EVENTS:**

First Relay: Begins at 8 AM. Half of the competitors will shoot their 3 P Smallbore program while the other will shoot the Air Rifle Program. The Relay will end at 11 AM and competitors will switch ranges for their next program. The ranges are located next to each other in the same building.

Second Relay: Will begin at 11:30 AM.

**SPECIAL INSTRUCTIONS:**

The USMA is a military facility and a security check is performed on each vehicle. For this you must email me:

- a) The name of the competitor who will be shooting.
- b) The make and serial number of the rifles that the competitor will be using.
- c) The make, model, plate number, and state of registration of the vehicle carrying the rifles.
- d) The name of the driver of that vehicle. The driver must show his driver's license with his photo as ID. Competitors may also have to show a photo ID.
- e) See "Directions to Range" sheet, which will guide you from the Stony lonesome Gate to the Tonsure Marksmanship Center.

## **Directions to West Point**

West Point is, as expected, on the west bank of the Hudson River, only 40 miles north of New York City. Traveling here from New York City takes about an hour and a half by [car](#), [train](#) or [bus](#).

## **Driving**

### **FROM NEW YORK CITY:**

Head north to the George Washington Bridge/I-95 South. Cross the bridge via the **upper** deck (no toll in this direction), and stay in the right lane, as immediately at the end of the bridge you will exit right on to the Palisades Interstate Parkway.

Take the Palisades Interstate Parkway north approximately 37 miles until it ends at the Bear Mountain Bridge traffic circle—unless you want the more leisurely and scenic route, do not get on 9W until you get to the Bear Mountain Bridge traffic circle. Proceed 3/4 of the way around the circle, following signs for West Point and Route 9W North. Stay on Route 9W for approximately 4.5 miles and exit right to the **Stony Lonesome Gate**.

**FROM SOUTH/NEW JERSEY:** Travel north on the NJ Turnpike/I-95, to exit 73 toward RT-67/Fort Lee--just before the George Washington Bridge. Stay left and take your first left at Lemoine Ave. Continue straight for ½ mile then bear right onto the Palisades Interstate Pkwy North. SEE DIRECTIONS FROM PALISADES INTERSTATE PARKWAY ABOVE.

### **FROM THE WEST:** *8 hours from Cleveland*

Travel east on Interstate 80 through New Jersey and take exit 43 to merge onto Interstate 287 northbound toward Mahwah. After entering New York, take the exit onto the New York State Thruway

South toward the Tappan Zee Bridge. Take exit 13N for the Palisades Parkway North toward Bear Mountain. SEE DIRECTIONS FROM PALISADES INTERSTATE PARKWAY ABOVE.

**FROM EAST/NEW ENGLAND VIA I-95:** *3 hours, 30 minutes from Providence*

Travel southwest on Interstate 95 into New York. Take exit 21 to merge onto Interstate 287 W toward White Plains and the Tappan Zee Bridge. Continue on I-287 W, and then take exit 13N for Palisades Parkway North toward Bear Mountain. SEE DIRECTIONS FROM PALISADES INTERSTATE PARKWAY NORTH ABOVE.

**FROM NORTH/NEW ENGLAND VIA I-84:** *4 hours from Boston*

Travel west on Interstate 84 until you cross the Newburgh-Beacon Bridge. Follow signs for Route 9W South (exit 10S). Stay on Route 9W for approximately 12 miles until you cross over a large mountain. As you are in your final descent off the mountain, you will encounter **three exits** on your right for West Point.

The first exit (labeled "RT. 218/293," NOT West Point) loops back under Route 9W, past the West Point golf course, and onto Route 218 to the Washington Gate. This gate is ONLY for DoD ID cardholders whose car has a current DoD decal and the gate has limited hours.

The second exit (labeled "West Point/Highland Falls/Rte. 218") loops over Route 9W directly to the **Stony Lonesome Gate**.

**Entrance Procedure:** There are two lanes of ingoing traffic here. Stay in the “ALL OTHERS” lane and stop at the checkpoint. Tell the Security Guard that you are “here for a Rifle Competition at the Indoor Rifle Range. Our contact person is Maj. Wigger”. **Driver: be sure to have a picture ID with you.** They may ask to inspect under your hood and in your trunk. They will check competitor’s names, their rifle S/N, and vehicles carrying rifles against a roster that I will have given the Force Protection Office (Security). It will contain the Driver’s name, make and model of vehicle, state of registration and the plate number. I must submit this information **the Thursday before each match.** Be sure that I have it. I will have also given the Force Protection Office (Security) a copy of our roster with names of competitors and their rifle make and S/Ns. Make sure that you **DO NOT HAVE ANY AMMO IN THE SAME CASE AS YOUR RIFLE.** Be courteous and cooperate fully. If they ask to see your rifle, open the case for them. If they ask you to take it out, be sure to open the bolt and use all safety procedures necessary. Sometimes they just ask for your name and rifle S/N and check it against the roster, so have it written down and keep it handy. It may save some time. If you are in a separate vehicle with not carrying rifles, just show your drivers photo ID and say that you will, be observing the rifle match.

**Post Rules:** The speed limit on Post is 25 MPH and is enforced. Stop for pedestrians in crosswalks.

### **Directions to range:**

When you leave the Security Check Point, **JUST FOLLOW THE DOUBLE YELLOW LINE.** It will lead you on a nice drive, up the hill and then down the hill (admire the scenery) and will bring you out along side Michie Stadium with Lusk Reservoir ahead of you. Turn left on to Mills Road and follow it down past the “Iron Mike” (Follow me!) memorial, Cadet Chapel, Cadet Jewish Chapel, and the Cadet Catholic Chapel. At the **STOP SIGN, TURN RIGHT** on to Washington Ave. Turn left at the next intersection (Ruger Rd.) and follow it down past Eisenhower Hall. At the bottom is a 5-road intersection. After Yielding, pass through the intersection keeping the Traffic Monument on your left. You will then be on **TOWER ROAD.** Follow **TOWER ROAD,** which will curve severely to the right, and down a slight hill. The one story building on your right is the **TRONSRUE MARKSMANSHIP CENTER.**
