**Location:** PGC is approximately 35 road miles west of downtown Charleston, SC. To map the range yourself, it is located 2.2 miles down Summer Rd. off Hwy 61 in Ridgeville, SC. For driving directions to the club, please refer to the maps on our web site at [www.palmettogunclub.org](http://www.palmettogunclub.org). From the homepage, click on "*Alternate Route to Range During Road Construction!*". The access road to our facility has been under improvements for the past year and although we expect the route to be fully operational ahead of this match, you should have the alternate route information with you just in case it not up to speed.

**Facilities:** The PGC Range has 40 paved and covered firing points.

RV parking is permitted and the club also has a pleasant area designated for camping. Clean rest rooms and a limited number of RV water and electric hook-ups are also available. Modern showers are also available on the club grounds.

If you plan to park an RV, camp out or practice at Palmetto Gun Club, please contact the match director or Club Manager before you unload your camping or competition equipment.

**Lodging:** Lodging accommodations are conveniently located within a reasonable driving distance of the range in Summerville and Charleston, SC.

**Food & Beverage:** There are no restaurant facilities at PGC or conveniently nearby and we recommend that you bring lunch, drinks, and a snack should you need more than the lunch provided each day by PGC. Lunch will be served at the match each day. We usually grill a few hot dogs and break out some chips and soda.

**Rules:** Current NRA Smallbore Rifle Rules will govern. The .22 Caliber Rimfire Rifle as defined in NRA Smallbore Rifle Rules 3.2 (Any Rifle) applies. Per Rule 3.21, the requirement for a smallbore empty chamber indicator (ECI) to indicate that the chamber is empty will be strictly enforced.

**Eligibility:** Open to all competitors; membership in the NRA is not required.

**Match Program:** For those who would like to practice, an open practice session will be held on Friday afternoon, April 15 from 3:30 to 5:30PM.

**Entries:**

**Individual Entries:** Individual entries will be made by completing and submitting the registration entry form on the last page of this match program, accompanied by your check or money order made payable to Palmetto Gun Club in the amount of the total entry fees (please do not send cash with entries submitted by mail). Be sure to indicate your correct NRA classification and NRA membership or NRA classification number if you have one.

**SR-1 Card:** SR-1 card is not required provide a complete and correct entry form is submitted (entry form on last page of this program).

**Entries Close:** Individual match entries must be received no later than April 16, 2010, 8AM.

**Entries Limited:** Entries are limited to 40 individual competitors

Advance entries will be accepted up to range capacity based on earliest postmarks. Entries beyond range capacity will be notified by e-mail or telephone on or about Nov 15.

**Post Entries:** Post entries will be accepted up to the stated range capacity. There is no additional fee for post entries but advance entries are appreciated.

**Note** - Junior competitors are not eligible for NRA award points or cash awards

**Return of Fees:** A full refund will be given to competitors who have sent an advance entry but are unable to attend.

**Squadding:** Squadding preference will be given to full program entries

**Classification:** The NRA classification system will be used in all individual matches. Competitors without an NRA classification will fire in the Master Class unless Rule 19.6 (assigned classification) or Rule 19.2 (temporary classification) applies. Competitors whose NRA classification cannot be verified online may be asked to present an NRA classification card or NRA Score Record Book For Temporary Classification at time of registration.

**Class & Category:** Class and category awards will be determined by the number of entries in each. Up to four categories may be used: Service, Civilian, Senior and Junior. Classes/categories with insufficient entries will be combined for awards. Members of the Army, Navy, Marine Corps, Coast Guard, Air Force, National Guard and Reserve components will comprise the Service Category (Rules 2.5, 2.6 and 2.7). All others are either Civilians (Rule 2.2), Seniors (Rule 2.2.1) or Juniors (Rule 2.3).

**Targets:** Official NRA Conventional targets will be used: A-51 at 50 yards and A-33 at 100 yards. Competitors will mark and hang their own targets before each match stage. Target clips are required and must be furnished by each competitor. Targets will be scored by the Statistical Office staff under the supervision of the Chief Statistical Officer. Scored targets will be available for inspection by competitors in the Statistical Office.

**Challenges:** Challenges and protests will be addressed as described in Rule 16. A \$2.00 challenge fee will be charged for each challenge and collected by the Statistical Office before making the first recheck. The fee will be returned if the challenge is sustained at any point along the line of rechecks. Challenge time limits for each match will be posted on the Statistical Office bulletin board.

Scoring Of Challenged Shots And Shots Of Questionable Value: In this tournament, the plug type scoring gauge will be restricted to use by range operating personnel including range officers, chief statistical officer, and one or more of the three members of the jury who will be selected prior to firing time. Competitors may not use a scoring plug under any circumstance.

**Awards Furnished By The NRA:**

**Individual Regional 2400 Championship Awards - Match No. 11, 2400 Grand Aggregate**  
Winner: NRA Regional Gold Medallion (Requires a minimum of 5 competitors)  
2nd Place: NRA Regional Silver Medallion (requires minimum 10 competitors)  
3rd Place: NRA Regional Bronze Medallion (requires minimum 15 competitors)

**NRA National Smallbore Rifle Championship Certificate Award:** Certificates for 50% off Camp Perry entry fees will be awarded to winners of each class with at least 10 competitors. Only one certificate will be awarded per class of 10 or more. Classes may be combined upward (NRA Rule 9.8.1) to make a class of 10 competitors. No certificates will be awarded if there are fewer than ten total competitors entered in this Regional tournament.

Competitors may earn a maximum of one prone certificate and one position certificate per year. Both certificates may be applied to the National Smallbore Rifle Championships if the certificate winner competes in both championships. Certificates won by an ineligible competitor will be passed down to the next lower competitor in that class (e.g., if the class winner has already won a prone certificate at an earlier Regional prone tournament or is a supported shooter). Certificates awarded to competitors

remain the property of the NRA which may refuse to honor any certificate for any reason at anytime,
