

2011 CONNECTICUT PRONE STATE CHAMPIONSHIPS

Date: August 13 & 14, 2011

Time: 9:00 a.m. – 1st Relay

If one relay, there will be approximately 20 Minutes in between each match. Firing should be completed by approximately 3PM each day with results posted shortly thereafter. Will go to 2 relays if over 50 competitors.

Location: Blue Trail Range, Wallingford, CT

Eligibility: Open to all as defined by NRA rule 2.3, NRA Membership is not required

Rule: NRA Rule 3.2

Classification: NRA classification system will be used. Temporary scorebooks are allowed. Classes with less than five competitors will be combined with the higher class.

Match 2 40 shots 100 yards, Metallic Sights, A-25 targets
Match 3 40 shots 50 meters, Metallic Sights, A-26 targets
Match 4 40 shots 50 yards, Metallic Sights, A-23/5 targets
Match 5 Iron Sight Aggregate (matches 1-4)
Match 6 40 shots Dewar match, Any Sights, A-23/5 & A-25 targets
Match 7 40 shots 100 yards, Any Sights, A-25 targets
Match 8 40 shots 50 meters, Any Sights, A26 targets
Match 9 40 shots 50 yards, Any Sights, A-23/5 targets
Match 10 Any Sight Aggregate (Matches 6-9)
Match 11 Grand Aggregate (Matches 5-10)
Match 12 Metallic Sight 2-man Team match
Match 13 Any Sight 2-man Team match

Note: *The top ten shooters in Match #1 will count for the CT State Championship Team – results compiled by NRA and no additional charge for this Match. So, please register and shoot so CT can claim their 2009 championship title.*
