**Taunton 60 shot prone match and 3P smallbore match**

**LOCATION:** 430 East Britannia Street, Taunton, MA 02780

**ELIGIBILITY:** This competition is open to all competitors. All competitors must be individual members of USA Shooting.

**CLASSIFICATION:** Will be determined based on current USA Shooting classification. Shooters without a classification will shoot in the AA class.

**RULES:** The latest edition of USA Shooting Rules will govern.

**SAFETY:** It is required by the Taunton Rifle and Pistol Club that all participants wear Safety Glasses and ear protection during the match. Shooters will NOT be allowed to shoot without eye and ear protection. Please don't sign up for these matches if this is an issue for you.

**COURSE OF FIRE:**

*Note that Matches 1 and 4 are run concurrently. Match 5 will be shot during the completion of Matches 1&4 and will be occurring at the same time as completion of Match 2.*

**Men's 60x40x40 Smallbore Rifle – Match #1 and #2**

(Match #1 will be the 60 shot prone aggregate,

Match #2 will be the first 40 shots of prone combined with offhand and kneeling)

60 Shots Prone – Fired in 3 stages – 30 minutes per stage

40 Shots Offhand – Fired in 2 stages – 45 minutes per stage

40 Shots Kneeling – Fired in 2 stages – 37.5 minutes per stage

*There will be a 3 minute target changing period after each stage*

*There will be a 3 minute target changing period followed by a 10 minute position changeover which includes the preparation period for the following position*

**Womens Prone - Match #4**

60 Shots Prone – Fired in 3 stages – 30 minutes per stage

**Women's 3x20 Smallbore Rifle – Match #5**

20 Shot Prone, 20 Shots Offhand and 20 Shots Kneeling.

2 Hours and 30 Minutes block time.

*There will be a 10 minute preparation period prior to the beginning on the block time.*

**FIREARM:** Any .22 caliber rifle conforming to rule 7.4.4

**SIGHTS:** Any metallic sight conforming to rule 7.4.2.3

**DISTANCE:** 50 feet

**TARGETS:** USA 50

**COACHING:** Coaching on the firing line will not be permitted.

**PROTESTS:** A scoring protest of \$1.00 per shot may be charged.

**TIES:** All ties will be broken in accordance with USA Shooting Rules.

**AWARDS:** Trophy will be awarded for the following categories:

High Man

High Woman

High Junior

If there are 3 competitors in J3 or J2 classes awards shall be given

(If there are less than three entries in any class, the class will be moved into the next higher class)

**ENTRY:** Entries may be made via e-mail, phone or mail to the contact person shown at the top of the first page.

**ENTRY FEES:** A fee of \$20.00 per individual will be charged.

**ENTRIES CLOSE:** Entries are limited to 13 total competitors (13 per relay).

Advance entries will close Saturday, December 10th. Entries will be accepted to range capacity.

Every effort will be made to accept all competitors who enter before the closing date. Another relay could be opened if the relay is filled but shooter should realize this match is being run on New Year's Eve Day.

**POST ENTRIES:** Entries made after the closing date will be accepted up to range capacity.

**CANCELLATIONS:** Cancellations received one week in advance, or earlier, will receive a full refund. An additional refund schedule may be used.

**EVENTS:** Relay 1: 8:00am

Preparation time will begin 10 minutes prior to the official relay start time. The range will be open at least one hour prior to the relay time.
