ELIGIBILITY: This competition is open to Junior competitors. All Junior competitors must be individual members of the NRA.

CLASSIFICATION: Per NRA Sectional Bulletin 2013.

RULES: The latest edition of NRA Conventional Shooting Rules will govern.

SAFETY: It is required by the Taunton Rifle and Pistol Club that all participants wear Safety Glasses and ear protection during the match. Shooters will NOT be allowed to shoot without eye and ear protection. Shooting glasses such as Knoblocks, personal eye glasses or safety glasses must be used. Please do not sign up for these matches if this requirement is an issue for you. The use of open chamber indicators is mandatory.

COURSE OF FIRE:

MATCH 1: Individual Match - 10 shots prone, 1 minute per record shot.

MATCH 2: Individual Match - 10 shots standing, 1 1/2 minutes per record shot.

MATCH 3: Individual Match - 10 shots sitting, 1 minute per record shot.

MATCH 4: Individual Match - 10 shots kneeling, 1 minute per record shot.

(One shot per bull's-eye. Matches must be fired in the order listed above.)

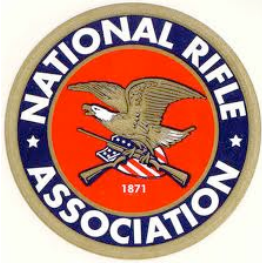
MATCH 5: Sectional Individual Conventional Position Smallbore Rifle Championship (An aggregate of Matches 1, 2, 3, and 4).

MATCH 6: Sectional Team Championship (Paper Match).

MATCH 7: National Indoor Individual Conventional Position Smallbore Rifle Championship.

MATCH 8: National Indoor Team Conventional Position Smallbore Rifle Championship.

Time Limit: Firing time is one minute per record shot in each position except standing, which is 1 1/2 minutes per shot. Each 10 shot string will be timed separately. There will be a 5 minute equipment change and a 3 minute preparation period between matches (Rule 8.2).

FIREARM: Any .22 caliber rifle conforming to Conventional Smallbore rules.

SIGHTS: Metallic sights only

DISTANCE: 50 feet

TARGETS: NRA/USA 50

COACHING: Coaching on the line will not be permitted. Competitors only will review targets during the challenge period.

PROTESTS: A scoring protest of \$1.00 per bull will be charged.

TIES: All ties will be broken in accordance with NRA Rules.

AWARDS: Appropriate awards will be provided based on the number of competitors and will be provided as outlined by the NRA Sectional outline on the NRA website. Awards will be given for each listed Match to at least the winners of that category.

ENTRY: Entries may be made via e-mail, phone or mail to the contact person shown at the top of the first page. Email is preferred.

ENTRY FEES: A fee of \$20.00 per individual will be charged for participation in the match.

ENTRIES CLOSE: Entries are limited to the capacity of the range (13 per relay). Advance entries by mail will close Wednesday, January 23, 2013. Entries will be accepted to range capacity. Every effort will be made to accept all competitors who enter before January, 26 2013 at 9 pm. The match director reserves the right to add or change competitors up until a relay begins the prep period.

POST ENTRIES: Entries made after the closing date will be accepted up to range capacity.

CANCELLATIONS: Cancellations received one week in advance, or earlier, will receive a full refund.

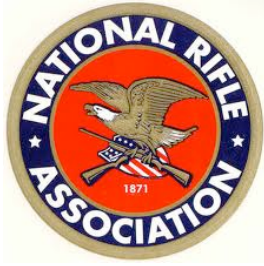

Relay 3: Noon (if needed)

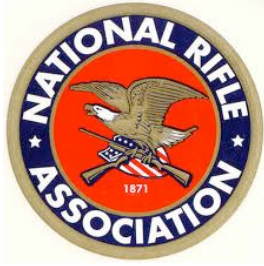


NRA Sectional
