JUNE -22 & 23, 2013

PLACE: New Freedom, Pennsylvania. Exit # 4 off I-83 to PA Route 851 through Shrewsbury, through New Freedom, to Bowser Road just outside New Freedom. West two miles, look for sign on tree on right. Nearest motel Hampton Inn just off I 83 Other motels are in York, PA and Hunt Valley, MD, both about 30 minutes away. Breakfast and lunch will be available for purchase at the range. We have 30 covered firing points on concrete.

<u>TIME</u>: The first relay will be firing at 8:30 A.M., both days.

ELIGIBILITY: Open to individual . Need not be members of NRA

<u>CLASSIFICATIONS</u>: NRA classification will be used. Rule 19.6, Assigned Classification, or Rule 19.2, Temporary Classification will apply. Juniors may, if they wish, shoot for score only (no awards). Classes and categories that have enough entries (5) to stand alone will do so, while others will be combined for awards.

CATEGORIES: Civilian and Junior categories only.

RULES: Current NRA rules will apply.

SQUADDING: Competitors will be assigned on firing point for the entire tournament. Like classifications will be grouped when possible.

<u>RIFLE:</u> .22 Caliber as per NRA Rule 3.2 (Any Rifle)

AWARDS: Cash or NRA award points equal to more than 60% of entry fees returned to shooters. Each match will have a winner plus a winner in each class. If more than 5 junior shooter, for score only, NRA medal to high junior will be awarded. There is a award for 1600 &3200 25% of pot to 1600 shooters and 50% of pot to 3200 shooters

NRA AWARDS: Camp Perry, \$50 vouchers, in each class with a minimum of 5 shooters.

Winner: NRA Regional Gold Medallion

2nd Place: NRA Regional Silver Medallion (minimum of 15 shooters)

3rd Place: NRA Regional Bronze Medallion (minimum of 25 shooters)

<u>SCORING</u>: Challenges will be \$1.00. Ties will be broken by rule 15.7.

<u>COMPETITOR RESPONSIBILITY</u>: It is the responsibility of the competitor to arrive at the range sufficiently in advance of the schedule firing time (approximately 1 hour) to check in with the statistical office and to prepare for firing. Competitors who fail to report to the firing line when their relay is called may, at the discretion of the Match Director, forfeit the right to fire in the match.

COURSE OF FIRE:

Matches 1 & 6 – 40 shots at 50 yards, A-51 target
Matches 2 & 7 – 20 shots Dewar course at 50 yards, A-51 target
– 20 shots Dewar course at 100 yards, A-33 target
Matches 3 & 8 – 40 shots at 100 yards, A-33
Matches 4 & 9 –20 shots Reverse Dewar course at 100 yards, A-33 target
– 20 shots Reverse Dewar course at 50 yards, A-51 target

Matches 1,2,3,4 are fired on Saturday with metallic sights. Matches 6,7,8,9 are fired on Sunday with any sights.

Aggregate Matches Match 5 – Metallic sights, total of Matches 1, 2.3, and 4 Match 10 – Any sights, total of Matches 6, 7, 8, and 9 Match 11 – Grand Aggregate, total of Matches 5 & 10
