ELIGIBILITY: This competition is open to all junior competitors.

RULES: The latest edition of USA Shooting Air Rifle Rifle Rules will govern. These can be found on the USAShooting.org website

SAFETY: It is required by the Taunton Rifle and Pistol Club that all participants wear Safety Glasses and ear protection during the match. **Shooters will NOT be allowed to shoot without eye and ear protection.** Shooting glasses such as Knoblochs, personal eye glasses or safety glasses must be used. The use of open chamber indicators is mandatory.

DISTANCE FIRED: 10 meters (33 feet)

RIFLE: Must comply with USA Shooting Rules

SIGHTS AND TARGETS: Orion Air Rifle targets will be used. No rifle scopes may be used.

INDIVIDUAL ENTRIES: Open to any member of USA Shooting

TEAM ENTRIES: 3 person teams may be formed on the day of the match if four or more three person teams are present. Local awards provided only.

TIME LIMITS: Times will be as described in the USA Shooting rules and will be reviewed prior to the start of the match by the Chief Range Officer.

Course of Fire: 60 shot match for men 40 shot match for women.

MATCH SCHEDULE:

Relay 1 at 8:00 am.

Relay 2 at 11:00

Relay 3 (only if needed)

COACHING: Coaching on the line will not be permitted. Competitors only will review targets during the challenge period.

PROTESTS: A scoring protest of \$1.00 per target will be charged.

TIES: All ties will be broken in accordance with USA Shooting Rules.

AWARDS: Appropriate awards will be provided based on the number of competitors

ENTRY: Entries may be made via e-mail, phone or mail to the contact person shown at the top of the first page. Email is preferred. Text messages may be sent.

ENTRY FEES: A fee of \$20.00 per individual will be charged for participation in the match. Team entry fees will be \$10.00.

ENTRIES CLOSE: Entries are limited to the capacity of the range (13 per relay). Advance entries by mail will close Wednesday, March 6, 2014. Entries will be accepted to range capacity. Every effort will be made to accept all competitors who enter before March 12, 2014 at 9 pm. The match director reserves the right to add or change competitors up until a relay begins the prep period.

CANCELLATIONS: Cancellations received one week in advance, or earlier, will receive a full refund.
