

# 2014 New Hampshire NRA Outdoor Metric 3 Position Smallbore Regional and State Championship

<b>Competition Date</b>	Sat, June 14, 2013
<b>Sponsoring Organization and Location</b>	Hudson Fish & Game Club 53 Pine Rd. Hudson, NH 03051
<b>Directions</b>	From the Everett Turnpike: Take Exit 2 off the Everett Tpk. and follow the signs towards Hudson going over the Merrimack River. After crossing the Merrimack stay in the right lane and turn onto Rt. 3A South (Sam's Club on right and Wal-Mart on left). At 3 <sup>rd</sup> set of lights stay straight (right lane) to continue on Rt. 3A. Go about 1½ miles to next lights. (Watch for HFGC sign.) Turn left at lights onto Pine Rd. Club is ¼ mile on left.

<b>Rules</b>	<ul style="list-style-type: none"><li>• NRA Smallbore Rifle Rules will govern.</li><li>• Use of OBI/ECI is mandatory.</li><li>• Ear protection is mandatory.</li><li>• Eye protection is strongly recommended.</li></ul>
<b>Eligibility</b>	Open to all competitors. Membership in the NRA is recommended, but not required.
<b>Teams</b>	An unfired <u>two</u> person team match is also available. A team may register until the relay for any one team member is called to the firing line. No team may be created that includes a competitor who has already fired.
<b>Match Entry Fees</b>	<b>Individual fees are \$35.00 for any Open competitor.</b> This includes: <ul style="list-style-type: none"><li>• Entry fee of \$9.00 – <i>50% will be returned in awards</i></li><li>• Range fee of \$8.50</li><li>• NRA Regional registration fee of \$9.00</li><li>• NRA State registration fee of \$5.50</li><li>• GONH State registration fee of \$3.00</li></ul> <b>Individual fees are \$30.00 for any Junior competitor.</b> This includes: <ul style="list-style-type: none"><li>• Entry fee of \$4.00 – <i>50% will be returned in awards</i></li><li>• Range fee of \$8.50</li><li>• NRA Regional registration fee of \$9.00</li><li>• NRA State registration fee of \$5.50</li><li>• GONH State registration fee of \$3.00</li></ul> <b>Team entry is \$8.00 for the 2 person team.</b>
<b>Entries</b>	Contact the person above to reserve an entry. Entries close Tues, June 12, 2014. Post Entries will be accepted until the relay is called to the firing line. A Post Entry fee of \$5.00 will be added.
<b>Entry Limit</b>	The match is limited to 16 competitors.

<b>Squadding</b>	Firing Points will be assigned by the Statistical Office. MA and EX will be squadded together as possible. SS and MK will be squadded together as possible.
<b>Relays and Start Time</b>	<p>The match in one relay limited to 16 competitors, shot in the following order.  <i>Prone relay 1, Standing relay 1, Kneeling relay 1</i></p> <ul style="list-style-type: none"> <li>Relay 1: firing begins at 9:30 AM</li> </ul>
<b>Matches:</b>	<p>All shots fired on A-51 targets with the following time limits:</p> <ul style="list-style-type: none"> <li>Match 1: 40 shots Prone – Two 20 minute strings</li> <li><b>Match 2: 40 shots Standing – Two 40 minute strings</b></li> <li>Match 3: 40 shots Kneeling – Two 30 minute strings</li> <li>Match 4: 3 Position aggregate State Championship Match – matches 1, 2 &amp; 3</li> <li>Match 5: 3 Position aggregate Regional Match - matches 1, 2 &amp; 3</li> <li>Match 6: Unfired 2 person Team Match – based on individual aggregates from Match 4</li> </ul>
<b>Equipment:</b>	<ul style="list-style-type: none"> <li>Any .22 caliber rimfire rifle conforming to NRA rule 3.2.</li> <li>Any sights – rule 3.7(c)</li> </ul>
<b>Awards</b>	<p><b>Regional Medallions</b> - awarded based on the number of competitors.</p> <ul style="list-style-type: none"> <li>Gold Champion Medallion if 5 or more.</li> <li>Silver Medallion if 10 or more.</li> <li>Bronze Medallion if 15 or more.</li> </ul> <p><b>Camp Perry Certificates</b> - Certificates to 50% Off Camp Perry entry fees will be awarded to Class winners of Match 5. One award per class. At least 10 competitors must be in a class to win a certificate. Certificate award guidelines will be posted at the match.</p> <p><b>Classification Awards</b> - 50% of Entry Fees will be returned as Award Points for Matches 1 - 4 in classification awards based on the number of competitors. 1<sup>st</sup> place for 5 entries, 2<sup>nd</sup> place for 8 entries, 3<sup>rd</sup> place for 13 entries, etc.</p> <p><b>Category Awards</b> – Award plaques will be given to the aggregate Junior State Champion and to the aggregate winners of each Junior category.</p> <p>NOTE: The Regional aggregate and the State aggregate will be identical. Therefore, class and category aggregate awards will be presented for the State Championship (Match 4) only.</p> <p><b>State Championship</b> - Only competitors who reside in New Hampshire may earn the State Champion title. An award plaque will be given to the NH State Champion. <i>(In the event the State Champion is a junior, a Junior State Champion plaque will be awarded to the next highest scoring junior.)</i></p> <p><b>Team Awards</b> – Award Plaques to 3<sup>rd</sup> place will be provided based on the number of teams in Match 6.</p> <p><b>Souvenir Pins</b> - A Souvenir Regional Participation Pin will be given to each competitor.</p>
<b>Classification</b>	This is an “Outdoor Metric Position SBR” match. The NRA Classification system will be used. Unclassified competitors will compete in the Master Class. Rule 19.6 – Assigned Classification; or 19.2 – Temporary Classification may be used.
<b>Challenges</b>	A challenge fee of \$2.00 will be charged for each challenge made. All shots fired during that stage will be rescored when a challenge is made.
